NOTICE OF ORDINANCE ADOPTION

NOTICE IS HEREBY GIVEN that at its regular meetings on January 23, 2008, May 28, 2008, July 23, 2008, August 27, 2008, September 24, 2008, and October 22, 2008 the Governing Board of the Tahoe Regional Planning Agency adopted ordinances entitled as follows:

- No. 08-1 Amendment of TRPA Code, Chapter 71 Tree Removal and Other Related Amendments to Allow Tree Removal for Defensible Space Purposes to be Approved by a Defensible Space Assessor

- No. 08-2 Amendment of the South Y Industrial Area Community Plan SEZ Restoration Credit Incentive Program and Policies to Include Alternative Fuels as Credit and Provide for Other Matters Properly Related Thereto

- No. 08-3 Amendment of Map Showing Need for Water Quality Improvements Pursuant to Requirements of Chapter 37, Individual Parcel Evaluation System (IPES)

- No. 08-4 Amendment of Chapter 79, Fish Resources, to Prohibit the Introduction of Aquatic Invasive Species into the Waters of the Lake Tahoe Region; to Require that All Watercraft Being Launched into the Waters of the Tahoe Region be Subject to Inspection; to Prevent the Introduction of Aquatic Invasive Species; to add Related Amendments to Chapter 2 Definitions; and Other Matters Related Thereto

- No. 08-5 Amendment of Code of Ordinances, Chapter 2, to define multi-residential facilities, an Amendment to Code of Ordinance sub-paragraph 20.3.B(3) to allow subdivision of residential projects of 5 or more units utilizing 50% coverage and an Amendment to Code of Ordinance subsection 35.2.F to allow subdivision of units of use for which bonus units have been substituted and provide for other matters properly related thereto

- No. 08-6 Amendments to the Code of Ordinances Chapter 20, Land Coverage, Chapter 2, Definitions, and 25, Best Management Practices to allow for the Conversion of Turf Athletic Grass to Synthetic Turf for Existing Public Athletic Fields and Provide for Other Matters Related Thereto

- No. 08-7 Amendment to Section 4.7 of TRPA's Code of Ordinances Regarding Project Approvals and Appeals

- No. 08-8 Amendment of Plan Area Statement 082, Upper Kingsbury, to Add "Eating and Drinking Places", "General Merchandise Stores", and "Outdoor Recreation Concessions" to the Permissible Use List, and Providing for other Matters Properly Related Thereto

- No. 08-9 Amendments to the Code of Ordinances Chapter 79, Fisheries, to require that all boat launch facilities in the Tahoe Region be closed when there is not an aquatic invasive species inspector present or other approved methods are used to insure inspection of watercraft prior to launching and Other Matters Related Thereto
- No. 08-10 Certification of the Final Lake Tahoe Shorezone Ordinance Amendments EIS and Adoption of Amendments to the Shorezone Code of Ordinances, Plan Area Statements, Community Plans and other Amendments Related Thereto
